

## **Petition for Commercial Vehicle Parking Permit**

The undersigned is aware that any individual, employee, employer or property owner who provides false information to the Traffic Commission for the purpose of obtaining a 24-hour Commercial Vehicle Parking Permit may be subject to criminal prosecution.

## **Documents necessary to forward petition to the Traffic Commission:**

- <u>Signatures</u> of the five heads of household on each side of petitioner's house as well as 10 heads of household for residences directly across the street from petitioner's house. ONLY ONE PERSON MAY SIGN PER ADDRESS AND MUST BE THE OWNER OR OCCUPANT.
- 2. A photograph of the Commercial Vehicle.
- 3. Lease agreement if this is a rental property.
- 4. <u>Affidavit from Employer</u> verifying on-call status and indicating approximate number of times per month the employee will be called in to work.
- 5. <u>Any other proof of on-call status</u> and typical work assignments that may assist in determining the on-call status of the petitioner. For example: Time-stamped work orders, receipts, dispatch logs, driver logs, etc.

6. <u>Receipt</u> that indicates payment of \$50.00 processing fee (payable at Dearborn Police Records Bureau).

NOTE: The commercial vehicle permit will only be valid for one year from the time officially approved, or sooner if the petitioner has moved from the property as described in the permit application. The permit is not valid if the petitioner has moved to another location. See ordinance 18-356 for further information. The petitioner must re-apply annually if requesting future permits. Fail to comply and re-apply as needed may subject the petitioner to enforcement action.
