

Petition for Permit Parking on a Residential Street (Residential and Handicapped)

Documents necessary to forward petition to the Traffic Commission:

- 1. <u>A letter</u> formally requesting permit parking, the specific location of the proposed parking space, and detailed reasons for the request.
- 2. <u>A diagram</u> of the applicant's lot, showing location and dimensions of the lot, structures, and driveway (if a side drive is not available, it should be noted in the letter referred to in item #1).
- 3. **A photograph** of the applicant's residence, street, and proposed location of the permit parking space.
- 4. <u>A list of signatures</u> of approval from the property owners on either side of the applicant's residence as well as the property owners of the residence directly across the street and on

each side of the residence directly across the street. (Five signatures in total should be submitted).

- 5. <u>If the request is because of a disability</u> (valid for 5 years, must re-submit permit application and proof of disability for each renewal)
 - a. <u>A letter</u> from the applicant's doctor stating the need for the permit parking request.
 - b. A copy of the State issued handicap parking permit.
 - c. A copy of the registration of the vehicle to be used by the disabled person
