

### SANDWICH BOARD SIGN INFORMATION & APPLICATION

Sandwich board sign – shall mean any sign that is constructed of two flat pieces joined at the top with a hinge device so that the sign stands up as an inverted "V."

#### **Sandwich Board Use**

- Each side of the sandwich board sign shall not exceed three feet in height or two feet in width.
- A stanchion or support up to 12 inches in height is permitted for the sandwich board sign.
- The bottom shall be weighted or anchored so that the sign is stable, windproof, and not easily knocked down.
- Permits for sandwich board signs shall only be issued for the period of April 1 through October 31.
- Sandwich board signs shall be <u>prohibited</u> between November 1 and March 31 a <u>new</u> permit shall be applied for each year.
- All sandwich board signs must be stored indoors at the close of the business each day.
- Sandwich board signs shall be place on private property whenever possible.
- In the event that placement on public property is necessary, the applicant must obtain permission from the Director of Property Maintenance and Development Services (PMDS), or his designee, to occupy the easement, right-of-way, or other public area, which permission may be rescinded in the discretion of the director.
- Sign owners, lessees, and manufacturers shall be liable for any and all claims, injuries, or damages that arise from placement of a sandwich board sign on public property.
- A permit for a sandwich board sign shall be revoked whenever, in the opinion of the Property Maintenance and Development Services Director, or his designee, the sign becomes an eyesore, a nuisance, or is neglected.
- Sandwich board sign sticker issued must be placed in the top right hand corner of the sign for the duration of the allotted time period.
