You will be responsible for making your current tax payment(s) using any other payment option offered by the Treasurer's office. Once enrolled in the program, you will still receive your courtesy summer and winter tax bills by mail, with a notation on the bill stating that the amount(s) due will be paid by automatic withdraw (ACH Enrollment Plan) from the authorized bank account.
- Payments made "between or in addition to" the scheduled summer installment dates <u>DOES NOT stop the next automatic</u> installment withdraw from occurring as "scheduled" by the resident, until the ENTIRE bill is paid in FULL.
- If the City is unable to debit your bank account for the tax amount due because of non-sufficient funds (NSF), you will be responsible to pay all interest/penalty accrued on your tax account. You will be invoiced a \$30 NSF Fee and your Automatic Tax Bill Payment Program will be discontinued. All future applications for the program will no longer be honored.
