TO THE QUALIFIED ELECTORS OF THE CITY OF DEARBORN:

PLEASE TAKE NOTICE that any qualified elector of the City of Dearborn who is not already registered, may register to vote at the office of the City Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at www.mi.gov/vote and mailed to the City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the City Clerk is **Monday, October 21, 2024**.

After this date, anyone who qualified as an elector may register to vote in person with proof of residency (MCL 168.492) at the Dearborn City Clerk's office, located at 16901 Michigan Ave., Dearborn, MI 48126 at the following times:

- Regular business hours: Monday-Friday from 8:00 a.m. to 5:00 p.m.
- Saturday, November 2 from 7:00 a.m. to 3:00 p.m.
- Election Day, Tuesday, November 5 from 7 a.m. to 8 p.m.

Additionally, the Dearborn City Clerk's Office will offer voter registration in person with proof of residency (MCL 168.492) at the Ford Community & Performing Arts Center, located at 15801 Michigan Ave., Dearborn, MI 48126 at the following times:

- Sunday, November 3 from 9:00 a.m. – 5:00 p.m.

**INTERMEDIATE SCHOOL DISTRICT – WAYNE COUNTY REGIAL EDUCATIONAL SERVICE
AGENCY RENEWAL OF REGIONAL ENHANCEMENT MILLAGE PROPOSAL**

As a renewal authority which expires with the 2027 levy, shall the limitation on the amount of ad valorem taxes which may be imposed on taxable property in the Wayne County Regional Educational Service Agency, Michigan, be increased by 1.9812 mills (9\$1.98 per thousand of taxable value) for a period of six (6) years, 2028 to 2033, inclusive, to provide operating funds to enhance other state and local funding for local school district operating purposes? It is estimated that 1.9812 mills would raise approximately \$108 million when first levied in 2028.
