If an Industrial Development District is established and an Industrial Facilities Tax Exemption Certificate is approved with reference to a particular development project, and Industrial Facility Tax would be payable by the applicant determined by multiplying one-half of the total mills, except for the State Education Tax (SET), levied as an ad valorem tax for a given year by all taxing units within which the facility is situated by the taxable value of the facility excluding the land for up to a twelve-year period.

Representatives from the property owners and lessee within the proposed district, the administration and residents and taxpayers will be afforded a full opportunity to question and comment upon the proposed establishment of the "Warren Avenue Corridor Industrial Development District" at the public hearing on [Insert Date and Time] in the City Council Chambers, Dearborn Administrative Center, 16901 Michigan Avenue, Dearborn, Michigan.
