1. CALL TO ORDER

Director Jay Kruz called the meeting to order at 9:06 am.

2. ROLL CALL

A role call for Board Members was called. A quorum was present.

3. APPROVAL OF THE EAST DDA MINUTES

A motion to approve the East DDDA meeting minutes of February 24, 2025 was made by Vice-Chair Zaineb Hussein, seconded by Director Debra Guido-Allen. The motion passed unanimously. Minutes approved.

4. REVIEW AND FILING OF TREASURER'S REPORT

Courtney Skora from Finance (City) reviewed the financial statement dated February 28, 2025. Revenue to date totaled \$1,041,905. Total expenditures were \$473,667. The equity in pooled cash position equals \$2,192,069 and it is estimated the EDDDA's cash position at the end of the fiscal year will be \$1,342,247.

5. EAST DDA ACTION ITEMS

a. **Resolution ED 25-03-01** was introduced to approve the purchase of new planter pots up to \$30,000 from the "Streetscape Enhancements" account number. These planter pots will contribute to the aesthetic streetscape enhancement. The motion was made by Vice-Chair Zaineb Hussein and seconded by Director Jay Kruz. A voice vote passed unanimously. Motion approved.

- d. **Resolution ED 25-03-04** was introduced to accept the resignation of Director Amanda Bright McCanahan from the EDDDA board. The motion was made by Vice-Chair Zaineb Hussein and seconded by Director Jay Kruz. A voice vote passed unanimously. Motion approved.

Mayor Abdullah Hammoud mentioned that a 52 page magazine will be issued twice a year by the city where DDAs can have the chance to promote their businesses.
