1. CALL TO ORDER

Director Jay Kruz called the meeting to order at 10:33 am.

2. ROLL CALL

A role call for Board Members was called. A quorum was present.

3. NEW MEMBER WELCOME

The Deputy Director of the Economic Development Department, Angela Fortino, welcomed the new board member, Siham Said.

4. APPROVAL OF EDDDA MINUTES

A motion to approve the East DDDA meeting minutes of March 19, 2025 was made by Director Zaineb Hussein, seconded by Director Kamal Turfeh. The motion passed unanimously. Minutes approved.

5. REVIEW AND FILING OF TREASURER'S REPORT

Courtney Skora from Finance (City) reviewed the financial statement dated March 31, 2025. Revenue to date totaled \$1,122,790. Total expenditures were \$492,167. The equity in pooled cash position equals \$2,192,069 and it is estimated the EDDDA's cash position at the end of the fiscal year will be \$1,248,203.

6. EDDDA ACTION ITEMS

- a. Resolution ED 25-04-01 was introduced to approve a \$1,000 sponsorship for Green Brain Comic's Free Comic Book Day being held on May 3rd, 2025. The motion was made by Director Zaineb Hussein and seconded by Director Kamal Turfeh. A voice vote passed unanimously. Motion approved.
- b. **Resolution ED 25-04-02** was introduced to award \$18,000 from the Dearborn Forward Grant Program to Oasis Kitchen located at 13210 Michigan Ave to support installing an exterior mural. The motion was made by Director Zaineb Hussein and seconded by Director Kamal Turfeh. A voice vote passed unanimously. Motion approved.
- c. Resolution ED 25-04-03 was introduced so that The East and West DDDAs approve the amendment to the Dearborn Forward program requirement regarding project commencement, such that the current requirement stating: "An applicant must commence a project within 60 days of the application approval date" is replaced with the following: "Eligible expenses may be reimbursed from the date that the program application is submitted by the eligible applicant". The motion was made by Vice-Chair Jay Kruz and seconded by Director Zaineb Hussein. A voice vote passed unanimously. Motion approved.
- d. Resolution ED 25-04-04 was introduced to approve the allocation of \$2,000 from the funds designated for the Mix and Mingle to Summer Festivities. The motion was made by Director Zaineb Hussein and seconded by Director Kamal Turfeh. A voice vote passed unanimously. Motion approved.
- e. Resolution ED 25-04-05 was introduced to accept the planting proposals by Ground Control, including a reallocation not to exceed \$70,925.65 from the following account numbers: from Streetscape Enhancements: \$10,932.40; from Building & Business Incentives: \$42,000; from Snow Removal: \$6,430.00; from Non-Capital Equipment: \$4,000.00; from Dearborn Arts Month: \$1,700; from Photography: \$1,217; from Dearborn Restaurant Week: \$2,000; from Sanitation Contractual Services: \$2,646.25. The resolution also authorized the approval of a total planting contract cost of \$90,037 (\$76,437 in FY '25 and \$13,600 in FY '26). to fund the planting activities with inclusion of a warranty clause valid for defects in plant materials but excluding misuse, general wear and tear, or acts of God. The motion was made by Director Zaineb Hussein and seconded by Vice-Chair Jay Kruz. Director Kamal Turfah voted no but a voice vote passed based on majority. Motion approved.
