3. APPROVAL OF WDDDA MEETING MINUTES

A motion to approve the West DDDA meeting minutes of March 19, 2025 was made by Chair Tahrik Alcodray, seconded by Secretary-Treasurer Chris Small. The motion passed unanimously. Minutes approved.

5. WDDDA ACTION ITEMS

- a. Resolution WD 25-04-01: The WDDDA awards \$60,000.00 from the Dearborn Forward Grant Program: \$19,000.00 to The Great Commoner, \$10,000.00 to Treat You Batter, \$6,000.00 to Village Picture Framing & Art Gallery L.L.C, and \$25,000.00 to WCW HOLDINGS LLC. Director Sam Abbas motioned to approve and Vice Chair Devon O'Reilly seconded the motion. A voice vote passed unanimously. Motion approved.
- b. Resolution WD 25-04-02: The East and West DDDAs approve the amendment to the Dearborn Forward program requirement regarding project commencement, such that the current requirement stating:"An applicant must commence a project within 60 days of the application approval date" is replaced with the following: "Eligible expenses may be reimbursed from the date that the program application is submitted by the eligible applicant". Director Chris Small motioned to approve and Chair Tahrik Alcodray seconded the motion. The motion passed unanimously. Minutes approved.
- c. Resolution WD 25-04-03: The WDDDA agrees to fund the planting services provided by Ground Control, for a cost not to exceed \$17,832 from Planting Materials account number contingent upon inclusion.of a warranty clause valid for defects in plant materials but excluding misuse, general wear and tear, or acts of God. Director Chris Small motioned to approve and Director Sam Abbas seconded the motion. The motion passed unanimously. Minutes approved.
