WHEREAS: The City of Dearborn is a participating municipality or court in the Municipal Employees' Retirement System of Michigan ("MERS"), and

WHEREAS: Under Section 8 of the MERS Plan Document, all missed Defined Benefit mandatory employee contributions due to intervening Military service leaves shall be reflected in the participating employer's overall liability in the next annual actuarial valuation unless an alternative method is elected (default); no employee contributions will be required from the participant; therefore be it

RESOLVED: That effective May 6, 2025, the 34<sup>th</sup> Council of the City of Dearborn (or for a participating court, the Chief Judge by Administrative Order) does hereby adopt this resolution for all present and future employee divisions requiring that all missed employee contributions due to intervening Military service be handled by:

The member will be permitted to choose to remit some or all missed mandatory employee contributions within a time period equal to three times the duration of the military service from the date of reemployment, but not to exceed five years, and years of service credit shall be granted in proportion to the employee contributions received. Subject to the applicable collective bargaining agreement and the rights contained therein and applicable law, MERS' Military Service contribution procedures are subject to the MERS Plan Document. Changes to the Plan Document may impact MERS' ability to administer this election in the future;

WHEREAS: It is also requested that City Council authorize a Noise Ordinance waiver during the same Summer Market dates and times, and

WHEREAS: Additionally, The East Dearborn Downtown Development Authority (EDDDA) will host the Downtown Dearborn Movie Nights in Peace Park East on June 26th, July 24th, and August 21, 2025 with additional rain dates planned throughout the season as needed, and

WHEREAS: The EDDDA requests that City Council authorize a Noise Ordinance waiver during the same Downtown Dearborn Movie Night dates and times; therefore be it

WHEREAS: Under this program and in order to shorten the time to process acquisition for these services, the Purchasing Division will process solicitations using pre-qualified vendors who are placed on the list as sole contractors, and

WHEREAS: The listed vendors have submitted a request for qualification and passed evaluation by the Economic Development Department: Michigan General Contractors, Olson Cement, and Top Hat Masonry; therefore be it

RESOLVED: That City Council does hereby authorize a Statement of Qualifications (SOQ) list of qualified Vendors as sole contractors to perform Front Step Front Porch Replacement for a term of five-years in an amount not expected to exceed \$160,000 per year; be it further

RESOLVED: That the City reserves the right to add other Vendors to the contractor SOQ list, should Vendors emerge that meet the minimum qualifications; be it further

RESOLVED: That this contract shall be financed from the Community Development Fund, Economic Development, Grant Administration, Housing Rehabilitation Grant funds in the amount of \$80,000 for East Dearborn and a one-time allocation in the amount of \$80,000 from the ARPA70 project account, General Capital Improvement Fund, Economic Development, Capital Project Support, Contractual Services budget for West Dearborn; be it further effect.

WHEREAS: In Dearborn, where 40% of residents are under the age of 19, is uniquely positioned to benefit from Rx Kids Program and the City's diverse, multigenerational households, many of whom face economic pressures despite workingclass incomes, stand to gain significantly from the stability and dignity this program offers, and

WHEREAS: The Rx Kids Program provides each enrolled family with a one-time prenatal payment in the amount of \$1,500 and \$500 per month for the first six-months of the baby's life, addressing basic needs like food, housing, and transportation at a critical time, and

WHEREAS: It is respectfully requested that the Finance Director be authorized to accept and recognize the U.S. Department of Health and Human Services Grant award in the amount of \$1,000,000 in the Public Health, Intergovernmental Revenue, Federal, Other account and appropriate the same into the Public Health, Health and Welfare, Undistributed Appropriations account; therefore be it
