## **Section 3 Required Forms**

## 1. Section 3 Recruiting Summary

Contractors are required to fill out and sign the Section 3 Recruiting Summary document. Each Contractor bidding on this Section 3 project is required to identify and submit a listing "to the greatest extent feasible" what measures they took to recruit and hire "qualified" Section 3 Workers and Targeted Section 3 Workers.

## 2. Section 3 Worker and Targeted Section 3 Worker Self-Certification Form.

This is a (2) page document that will serve as an application to potential Section 3 and Targeted Section 3 Workers. The applicant will complete this document and self-certify eligibility as a Section 3 Worker.

#### 3. Section 3 Business Concern Certification for Contracting.

This is a (2) page document the contractor will fill out self-certifying that they are an eligible Section 3 Business Concern.
