Director's Report

Director Fletcher reported that the budget is being reviewed and the numbers look good.

Camp Dearborn is having a very good summer.

The Center continues to be busy.

The Disc has received two new sheets of ice. A new roof is being put out for bid. Once the roof is replaced, one ceiling will be painted. Looking at updating building paint colors.

Assistant Director Plamondon reported FY 25 Recreation revenues eclipsed \$10,000,000. This is with oil revenues being 1/5 of what they used to be.

Center revenues are coming back. Memberships are up.

Dearborn Hills back to 18 holes. Mystic Creek continues to do well

Revenues up at all locations. Up \$1,200,000 in revenue. Expenditures are up, but subsidy has stayed flat, which is good news.

Pool openings are on track. The locker rooms look great.

Question about condition of greens and turf at Dearborn Hills. Related to issues with irrigation. River and ponds need to be tested. Need to clear lines of sediment. Attempting to replace as many irrigation heads as possible. Hand watering is insufficient during times of high heat and humidity.

Inspection of Lapeer Pool is scheduled for August 12th. Opening on August 13th or 14th.

Chair Murray reported that she spoke to Jon Golich and John Kerr and next year's calendar will reflect that there will be no Recreation Commission meetings in December, July and March. The sports banquet will be in March.

Five Year Master Plan

Mike Hoffmeister from the Mannik & Smith Group presented an overview of the meaning of the Master Plan and the process of creating a new Five-Year Master Plan.

Have been evaluating and inventorying amenities the various park facilities offer residents.

Have been conducting stakeholder and public surveys.

Have had one public input session and will have two more.

Have had meetings with youth sports groups and cultural groups utilizing the Center.

Why a Five-Year Master Plan? It is a best practice. It is a requirement for any MDNR grant submission. Any project submitted for grant consideration must be in the Master Plan.

Plan is to take Master Plan to City Council in November.

- Indoor sport facility. Turf space.
- Bring back blue boxes at parks.
- Parents want their kids to be more socialized, less isolated, less attached to their phones.
