

Dearborn Crime Rates are Down!

Dearborn has seen a continued drop in crime, reflecting the City's investment in modern policing tools, officer training, and neighborhood safety initiatives. In 2024, overall crime was reduced by 7%, with significant declines in several key categories. These improvements are the result of strong leadership, proactive strategies, and the ongoing partnership between our public safety teams and the community.

New Inclusive Playground Coming to Lapeer Park!

Construction begins this spring on a new inclusive playground at Lapeer Park, with completion expected by July 1. Designed in Salina

School colors, it will feature shade sails, a sensory play center, a communication board, and accessible elements like a we-go-round, swing bank, and wildcat-themed DigiRider. Seating areas will provide space for families to gather and enjoy.



New Green Tents & Comfort Stations at Camp Dearborn

Camp Dearborn is introducing new "Green Tents" to replace those removed in 2021. Each tent includes bunk beds, a queen bed, dining table, and an outdoor

kitchen, and will be available year-round on I Row for \$95 per night.

In addition, a \$1.1 million contract has been awarded for major renovations to four comfort stations - the first in nearly two decades including updated fixtures, lighting, plumbing and showers.

City Ordinance Changes You Should Know About

Non-Commercial Soliciting

To align with U.S. Supreme Court precedent on free speech, the city has removed the permit and ID requirements for individuals engaging in non-commercial solicitation—such as promoting religious, political, or charitable causes door-to-door. Time-of-day restrictions and the ability to post "No Soliciting" signs remain in place. These changes apply only to non-commercial activity and do not affect commercial soliciting regulations, which still require a permit.

Parking

The parking requirements for new businesses have been eased, mirroring the parking exemption already in place in the West Downtown area. This change is part of the efforts to revitalize the East Downtown area, aiming to support business growth and attract new enterprises to the neighborhood.

Property Abatement Violations- (Effective April 1, 2025)

New rules require property owners or occupants to submit proof that abatement issues have been resolved—such as a photo—via email, phone, or the QR code/form link provided in the notice. If no proof is submitted before the deadline, a service charge of up to \$100 (50% of the City's abatement cost) will be added to cover administrative and contractor mobilization costs.

Revitalizing Our City

Demolition is underway of three long-vacant and dangerous apartment buildings at 5104, 5112, and 5120 Oakman Blvd. This action, in line with Michigan Statute and city ordinance, addresses public safety concerns and opens the door for future redevelopment opportunities.

SilverSneakers® & Prime Fitness Programs at FCPAC!

Adults 65+ with eligible Medicare plans can access basic fitness amenities at the Ford Community & Performing Arts Center through the SilverSneakers program. The Prime program offers similar access for adults 18+ through certain health plans or employers. Both programs include facility use during regular hours (Monday-Friday, 8 a.m.-6 p.m.), but do not cover group exercise SilverSneakers classes. Open to residents and non-residents.
