WHEREAS: On November 13 and 14, 2025, the City of Dearborn was placed on the Wayne County Board of Canvassers agenda for discussion regarding the "Re-tabulation for...the City of Dearborn" for the reason that certain absentee ballots that were counted on election night were incorrectly placed in retention bags instead of certified ballot bags creating a chain of custody issue, and

WHEREAS: County Officials became aware of the possible chain of custody issue due to absentee ballot totals in several Dearborn precincts not matching the number of absentee ballot totals on the verified voter roll, and

WHEREAS: The Wayne County Board of Canvassers was split 2-2 on whether to recount the unreconciled precincts and as a result, there was no recount, and

WHEREAS: The City Clerk's office did not provide notice of this issue to either the Administration or the Department of Law before the Wayne County Board of Canvassers deliberated on and decided the issue; therefore be it

RESOLVED: That pursuant to City Charter Sec. 10.4(1), this City Council hereby directs the City Clerk to immediately notify the Administration and Department of Law on any and all election related matters under the review and jurisdiction of the Wayne County Board of Canvassers, the Secretary of State, or State Board of Canvassers; be it further

RESOLVED: That this notice requirement placed on the City Clerk shall be applicable to all election matters occurring after the date of this resolution; be it further

RESOLVED: That this resolution be given immediate effect.
